I hope this message finds you well. I'm writing to let you know about an important change regarding Vertabelo, which affects your ongoing relationship with our services.

As of 18th September, the product Vertabelo Database Modeler has been acquired by Redgate Software. This means that all existing agreements for Vertabelo Database Modeler will now be overseen by Redgate.

We believe Redgate is the right home for the product moving forwards, and that the acquisition ensures a strong future for our customers.

With more than 25 years of experience supporting database professionals, Redgate helps over 200,000 companies worldwide – including 92% of the Fortune 100 – reliably solving complex challenges across the database DevOps lifecycle. You can learn more about Redgate's solutions on its <u>website</u>.

Redgate has no immediate plans to make changes to Vertabelo Database Modeler. You can continue to access and use Vertabelo Database Modeler as you do today, and Redgate remains committed to maintaining the same level of quality and service that Vertabelo is known for.

Redgate will be adapting the terms and conditions of the product subscription slightly, to bring them into line with other Redgate products. These changes, detailed at the foot of this letter, do not impact the product's functionality or level of service.

If you are comfortable with this transition, no action is required on your part. Your contract will automatically be transferred and Redgate will take over all associated responsibilities. The name of the product will change from Vertabelo Database Modeler to Redgate Data Modeler and that change will be reflected in your terms and conditions.

If you wish, you have the right to object to this transfer within three months of receiving this notice. If you would prefer your contract with Vertabelo to cease, and not be transferred to Redgate, please respond to this email letting us know your preference, and we will manage the cessation of the contract.

While the acquisition of Vertabelo Database Modeler closed yesterday, September 18 2026, Redgate will not be announcing the acquisition until October 7, to allow for rebranding across the product. Addendum: Detail of changes to terms and conditions as part of this acquisition

Following the acquisition of Vertabelo Database Modeler by Redgate, customers of Vertabelo Database Modeler will move to a new end user license agreement (EULA).

This EULA will reflect the legal change from Vertabelo to Red Gate Ltd, as well as the change in product name from Vertabelo Database Modeler to Redgate Data Modeler.

As Redgate is a UK-headquartered business, the EULA will be subject to UK law as opposed to Polish law.

The privacy policy is updated to reflect how Redgate manages and supports your data privacy. Details of Redgate's privacy policy are <u>here</u>.

There is a change in the liability clause, with a cap on Redgate's liability of twelve months of fee.

To comply with appropriate laws and regulations Redgate is registered for VAT and Sales Tax in a number of geographies, this may result in changes to the tax you are being charged for your next billing period.
